


Dual Enrollment Representation Gaps by Ethnicity (Percentage) 2022-2023



High School vs. Dual Enrollment Representation by Ethnicity



Dual Enrollment Representation Gaps by Ethnicity (Percentage) 2022-2023


















## The Access Gap Tool in Action

- Institutional Planning: Informed development of new Educational Master Plan and Strategic Enrollment Management Plan
- Joint Board Meeting: Facilitated discussion and goal-setting between K-12 and CC governing boards around dual enrollment
- Outreach Plan: Focused outreach and recruitment for Black/African American, Native American, Pacific Islander student groups through field trips, school presentations, student ambassador recruitment, Early College open enrollment.



#### **Data-Informed Goals**

#### **Educational Master Plan**

- Increase Dual E participation among Black/African American and Native American students.
- Increase number of HS students who matriculate into certificates or degrees.
- Focus Dual E data collection and sharing on equity and access.

## Strategic Enrollment Management Plan

- Increase access and outreach to high school students in underrepresented groups.
- Increase course offerings at South Valley Campus at the NVC American Canyon Campus.
- Hire dedicated Dual E counselors and support staff

## Early College Implementation Plan

- Engage in recruitment efforts targeted towards underrepresented groups.
- Ensure that EC student demographic mirror the demographic of the larger districts.
- Provide focused student and academic supports onsite.

## Mt. SAC Early College Academy



#### **Context**

- Opened in 2018 with 60 freshmen students as a stand alone early college
- Current enrollment: 265
- Our focus: IGETC guided pathway (52 units offered on our campus)
- 51% of students designated as socioeconomically disadvantaged
- 95% students of color





### How did the dual enrollment equity tool help us?

- Gaps identified:
  - 12th grade had the lowest participation rate
  - Latinx students were underrepresented

- Changes made:
  - Use of CCAP funding to open a drop-in tutoring center
  - Changes to our pathway to provide courses more aligned with student need/interest
  - Ongoing reflection about recruitment
